Lamar County Board of Commissioners Regular Business Meeting April 18th, 2017

Present for the meeting were Chairman Glass, Vice-Chairman Horton, Commissioner Heiney, Commissioner Traylor, Commissioner Thrash, County Administrator Zellner, County Clerk Davidson and County Attorney Mayfield.

I. Call to Order

Chairman Glass called the meeting to order at approximately 7:00 p.m.

II. Pledge of Allegiance and Invocation

Everyone said the pledge of Allegiance. Tommy Holton from Rock Springs Congregational Methodist Church gave the invocation.

III. Agenda Approval

Vice-Chairman Horton made a motion to approve the agenda with the addition of the approval of purchasing voting machines for the Board of Elections. Commissioner Thrash seconded the motion. The motion passed unanimously.

IV. Minutes Approval

Commissioner Traylor made a motion to approve the following three sets of minutes and Commissioner Thrash seconded the motion. The motion passed unanimously.

V. Proclamations

i. Commissioner Thrash read and presented a Proclamation to several members of the Rock Springs Congregational Methodist Church including Tommy and Lora Holton and Commissioner Traylor. Rock Springs Congregational Methodist Church was established in 1852 and was one of the first churches in the Congregational Methodist Denomination. Rock Springs Church was blessed to have Dr. Benny Tate come to be the Pastor in 1990 and under his leadership, the church has flourished from 25 members to over 7,000 members expanding to five campuses in addition to the main campus. Rock Springs Church provides multiple ministries including Rock Springs Christian Academy, Rock Springs Medical Clinic, and the Potters House for Women, and Impact Street Ministry for the Homeless and many others. Rock Springs Church believes that in order to impact the next generation there must be an investment in our children. Dr. Tate saw a need and after ten years of planning and many prayers, Rock

Springs Church recently completed construction of its Children's Ministry and Education Building. The three story structure being 39,000 total square feet, including a two story indoor playground, nineteen new children and nursery areas, ten large classrooms for the growth of the Sunday School program and two 2,200 square foot auditoriums for Children's-Church services. The Lamar County Board of Commissioners, recognized and honored Rock Springs Church for its contributions and investments in our community, and for leading souls to Jesus Christ making a lasting difference in lives.

ii. Chairman Glass read a Proclamation for National Donate Life Month where one of the most meaningful gifts that a human being can bestow upon another is the Gift of Life and where more than 121,000 men, women, and children await life-saving or life-enhancing organ transplants, of which over 5,590 reside in Georgia. The need for organ, eye, and tissue donation grows daily as a new patient is added to the national waiting list for an organ transplant every 10 minutes and he critical donor shortage remains a public health crisis as an average of 22 people die daily due to the lack of available organs. Organ, eye, and tissue donation can provide families the comfort of knowing the gift of donated organs and tissue endows another person with renewed hope for a healthy life. Donating life through organ, eye, and tissue donation is the ultimate act of generosity and kindness we Lamar County citizens can perform. More than 4.7 million Georgians have already registered their decision to give the Gift of Life and LifeLink of Georgia is the non-profit, community service organization dedicated to the recovery of high quality organs and tissues for transplantation therapy and Lamar County supports the life-saving mission of LifeLink and proclaims April as Donate Life Month.

VI. Lamar County Health Department

Sherry Farr County Nurse Manager Lamar/Upson County with the District 4, Georgia Department of Public Health gave an annual presentation to the board. Mrs. Farr made the following points in her presentation.

- 1. The operating budget comes from various sources including GGIA funding (20-40%), County contributions and Fees (minimal and variable) (20-50%).
- 2. The budget has increased from \$155,631 in 2012 to \$196,529 in 2016.
- 3. The county participation has increased from \$ 100,000 in 2012 to \$95,000 in 2016.
- 4. The fees based on income have gone from \$441,407 in 2013 to \$551,429 in 2016. The fees based on expenses have gone from \$454,413 in 2013 to \$527,007 in 2016.
- 5. The County health ranking and roadmaps have gone from 85 out of 159 in 2015 to 87 out of 159 in 2017. This ranking is calculated based on criteria received district wide.
- 6. Areas to explore include smoking, adult obesity, uninsured, unemployment, children living in poverty, and income inequality.
- 7. Low birthweight from 2011 to 2015 has fluctuated in Lamar County from 22.5 to 20 lbs.
- 8. Teen pregnancies from 2011 to 2015 have fluctuated in Lamar County from 11 to 7.
- 9. STD incidents from 2010 to 2014 for Youth ages 15-19 (per 1,000) have fluctuated in Lamar County from 60 to 25.

10. The goals for 2017 include working with community partners on ways to address community health needs, continuing to work on a Telehealth System for Behavioral Health needs and continuing to work on Public Health accreditation, maintaining a positive cash flow with a focus on increasing revenue and improving the facility. Currently Lamar County has applied for a Community Development Block Grant (CDBG) for the purpose of building a new Health Facility but the approval of this grant will not be announced until September or October of 2017.

VII. Voting Machines for the Board of Elections

Chairman Glass stated that the Board of Elections Supervisor Reed had found 32 DRE TSX voting machines offered by the state of California that had only been used one time and were being surplused. The voting machines normally sell for \$2000.00 each. The Board of Commissioners most approve purchases over \$7,500.00. Commissioner Traylor made a motion to approve the purchase of 32 voting machines for the Board of Elections for a purchase price of \$350.00 each. The software cost to program each machine is \$150.00. Vice-Chairman Horton seconded the motion. The motion passed unanimously.

XI. Public Comments

Sandra Puckett of 638 Yatesville Road addressed the board with several concerns. Ms. Puckett would like to have reflectors placed on Yatesville Road because at night it is hard to see the road. Ms. Puckett requested to have the portion of McCollum Road that is in bad shape to be resurfaced. Ms. Puckett also requested that Holly Grove Road be fixed since she has relatives on that road that she can't get to because of the road being in such bad shape. Ms. Puckett stated that she will not even drive her car down this road. Ms. Puckett also mentioned that trucks are still continuing to come down Yatesville Road. Chairman Glass advised Ms. Puckett to contact the Sheriff's Office regarding the trucks. Chairman Glass also stated that the Georgia Department of Transportation (GDOT) has some emergency funds that are designated for safety concerns to help with some of these issues and they may can use these funds to purchase the reflectors. Chairman Glass said that he would have Public Works work on both McCollum Road and Holly Springs Road.

XII. Round Table

Vice-Chairman Horton announced that his band would be playing at the BBQ and Blues Festival this coming Friday night.

Commissioner Heiney encouraged everyone to slow while driving down on country roads. Commissioner Traylor stated that he had spoken recently to the new Lamar County High School football coach and learned that he is very interested in getting involved in the community. Commissioner Traylor requested that everyone show him southern hospitality if you see him.

County Administrator Zellner gave an estimated material cost for fixing pavement issues on Bottoms Road and Harmony Hill Road. There was discussion about the swamp and the power lines on Harmony Hill Road. It was suggested that a Deep Reclamation be done to fix the road. Chairman Glass congratulated Commissioner Thrash on her appointment to the ACCG Executive Board. Chairman Glass also invited everyone to the BBQ and Blues Festival this coming Thursday, Friday and Saturday nights.

XIII. Adjournment

Commissioner Thrash made a motion to adjourn the meeting at 7:50 p.m. and Commissioner Traylor seconded the motion. The motion passed unanimously.
