# Lamar County Board of Commissioners Regular Business Meeting October 17<sup>th</sup>, 2017

Present for the meeting were Chairman Glass, Vice-Chairman Horton, Commissioner Heiney, Commissioner Traylor, Commissioner Thrash, County Administrator Zellner, County Clerk Davidson and County Attorney Mayfield.

### I. Call to Order

Chairman Glass called the meeting to order at approximately 7:00 p.m.

### II. Pledge of Allegiance and Invocation

Everyone said the pledge of Allegiance. Cindy McDonald with the First United Methodist Church of

Barnesville gave the invocation.

## III. Agenda Approval

Commissioner Traylor made a motion to approve the agenda and Commissioner Thrash seconded the motion. The motion passed unanimously.

#### IV. Minutes Approval

Vice Chairman Horton made a motion to approve the following three sets of minutes. Commissioner Thrash had one correction which was on the September 19<sup>th</sup> minutes. The correction was for the motion to table the App# 2017-01 by American Forest, Inc. which stated until the September meeting. This should have been for the October meeting. Commissioner Heiney seconded the motion to approve the three sets of minutes with the change from September to October. The motion passed unanimously.

#### V. Board Appointments

Commissioner Thrash made a motion to re-appoint L.D. Parks to the Planning Commission for a term of four years. The term will expire on 11/1/2021. Vice-Chairman Horton seconded the motion. The motion passed unanimously.

### VI. Minor Subdivision App. # 2017-01 by American Forest, Inc.

Commissioner Thrash made a motion to approve App. # 2017-01 by American Forest, Inc. then learned that Ordinance 2017-06 would need to be approved according to County Attorney Mayfield. Commissioner Thrash then amended her motion to approve Ordinance 2017-06 for the purpose of rezoning the property for American Forest, Inc. from Agricultural-Residential (A-R) to Single-Family Residential (R-2) instead of App. # 2017-01. Commissioner Thrash was instructed by Building and Zoning Director Gunter that both the App #2017-01 and the Ordinance 2017-06 would need to be approved. Commissioner Thrash amended her motion again to approve both App. #2017-01 by American Forest, Inc. and Ordinance 2017-06 for the purpose of rezoning the property from Agricultural-Residential (A-R) to Single-Family Residential (R-2) which is a rezoning classification (App #2017-01) for American Forest, Inc. Commissioner Traylor seconded the motion. The motion passed unanimously.

## VII. Proposed Rezoning of Official Zoning Map

Commissioner Thrash made a motion to table the proposed rezoning of the official zoning map and Commissioner Heiney seconded the motion. Commissioner Thrash then asked Building and Zoning Director Gunter if this proposed rezoning was spot zoning. Building and Zoning Director Gunter replied that it was not spot zoning that spot zoning is done with parcels. He said that this is for county wide zoning and is based on county code. Commissioner Thrash stated that as a Commissioner they are there to represent the people. The people that are zoned A-R want to have cows, ducks, turkeys and if they change the zoning they are getting involved in people's lives. Commissioner Thrash said that as elected officials they have a responsibility to represent the people. Chairman Glass suggested that they have a specific quorum at the planning commission meeting so that this could be covered before they vote on this the next time. Chairman Glass called for a vote. The motion passed unanimously.

### VIII. Ordinance 2017-05 Media Permit

Chairman Glass explained that the Media Ordinance was revised based on the feedback from those involved with the filming of the movie 'Sharp Objects." Commissioner Thrash made a motion to adopt Ordinance 2017-05 Media Permit and Commissioner Traylor seconded the motion. The motion passed unanimously.

### X. Round Table

Commissioner Horton said that he commended the citizens that were in the house with their concerns and noted that it was Government at work. Commissioner Horton also said that the Oktoberfest at Summers Field was a success.

Commissioner Heiney echoed Commissioner Thrash and stated that these decisions effect people. Commissioner Heiney stated that he had spoken to Haskell Taylor who lives on Zellner Road who was concerned about going from A-R to R2 because he was afraid he wouldn't be able to have his chickens. Commissioner Heiney stated that he lives on a country road and he is glad to see that they tabled this vote. He said he doesn't like taking away from people what they already have. Commissioner Heiney stated that it shouldn't be in your face government.

Commissioner Traylor stated that there still needs to be a plan in place but he agrees that they shouldn't allow it to change Barnesville. Commissioner Traylor was at a Legislative Leadership Conference and Commissioners from Henry County were talking about zoning changes that they wish that they had not made. Commissioner Traylor thanked Mr. Felton for what he is doing for the Veterans and requested that everyone give him a round of applause. Commissioner Traylor shared the fact that Mr. Felton had made a request to have signs placed on Hwy 36 and McCollum Road and even though it is not the County's jurisdiction they still submitted the request.

Commissioner Thrash re-iterated Commissioner Traylor and thanked Mr. Felton. Commissioner Thrash said that we do the veterans an injustice especially with all the experiences they have been through. Commissioner Thrash said that she appreciated what Mr. Felton was doing and offered to help in any way she could.

Chairman Glass said that he understood the need for Mr. Green but said that they couldn't commit County resources to just one individual. The County can't afford to do it for just one citizen. Chairman Glass announced that the Blood Drive for Lamar County is this Thursday from 1:00 p.m. to 6:00 p.m. at the First Methodist Church of Barnesville. The last blood drive they collected 73 units and had more than they needed. Chairman Glass said that the Women's League makes homemade cookies to be distributed to those that give blood.

### XI. Executive Session and Adjournment

Vice-Chairman Horton made a motion to recess the meeting at 8:45 p.m. to go into executive session to discuss litigation. Commissioner Thrash seconded the motion. The board adjourned the executive session meeting at approximately 9:03 p.m. Commissioner Thrash made a motion to adjourn the Regular Business meeting at 9:06 p.m. and Vice-Chairman Horton seconded the motion. The motion passed unanimously.
