AN ORDINANCE FOR THE PURPOSE OF REZONING PROPERTY IN LAMAR COUNTY, GEORGIA AND TO AMEND THE OFFICIAL ZONING MAP OF LAMAR COUNTY, GEORGIA

WHEREAS, Kevin Fabian, has applied for rezoning of approximately 2.01 acres from R-3 (Residential 3) to R-4 (Residential 4) to allow approximate 800 square feet modular home to be moved on the property. Proposed use home for elderly parents. The property is located at the corner of I-75 and High Falls Road, in Land Lot 233 of the 3rd Land District, as shown on Tax Map 086 Parcel 085; and recorded in Deed Book 801, Page 253.
