AN ORDINANCE FOR THE PURPOSE OF REZONING PROPERTY IN LAMAR COUNTY, GEORGIA AND TO AMEND THE OFFICIAL ZONING MAP OF LAMAR COUNTY, GEORGIA

WHEREAS, Patrick Brown, has applied for rezoning of approximately 1.00 acre from A-R (Agricultural- Residential) to R-4 (Residential 4) to allow a 900 square feet house to be moved on the property.
