## LAMAR COUNTY BOARD OF COMMISSIONERS REZONING ORDINANCE NO. 2018-04

AN ORDINANCE FOR THE PURPOSE OF REZONING PROPERTY IN LAMAR COUNTY, GEORGIA AND TO AMEND THE OFFICIAL ZONING MAP OF LAMAR COUNTY, GEORGIA

WHEREAS, Fisher Holloway Properties, LLC, has applied for rezoning of approximately 2.20 acres from M-1 (Manufacturing-Light) to A-R (Agricultural-Residential) to allow a boarding kennel. The property is located at 176 Crawley Road Land Lot 250 of the 2nd Land District, as shown on Tax Map 016, Parcel 007B; and recorded in Deed Book 893, page 680.
