Workshop Meeting Lamar County Board of Commissioners 12-10-2024 9:15 A.M.

Call to Order

The meeting was called to order at approximately 9:15 A.M. on December 10t^h, 2024. Present for the meeting were Chairman Traylor, Vice-Chair Gilles, Commissioner Fletcher, Commissioner Lovett, Commissioner Thrash, County Administrator Townsend, County Clerk Davidson. Commissioner Gilles and County Attorney Mayfield joined the meeting via Teams.

Workshop Meeting Items for Discussion

Capstone Fall Presentation

Recreation Director Tiffany Lowe (Mrs. Lowe) presented the Capstone Fall Presentation Master Plan Development, which included discussions on various development plans for the county's recreational areas. The Background of the project includes, outdated recreational facilities, historical lack of planning, limited parking and traffic arrangements, assistance in delegating funding. The requested deliverable for the project is a comprehensive facility and a site master plan and opinion of probable cost.

Current Conditions & Challenges:

No records of past development in the park, Limited parking:(270 spaces; peak traffic around 1,000 cars), Visitors park on side of the road and on hills, Outdated lighting poses safety issues.

Growing Issues:

Growing population (influx from South of Atlanta), Community dissatisfaction with conditions of facilities, The need to modernize

Facility Assessment Construction Work, Site Improvements Detailed Architectural Design, New Facility Recommendations Operations and Maintenance Planning, Traffic and Parking Analysis Private Land Acquisition, Cost Estimation Legal and Regulatory Approvals and Community Feedback Programming and Event Planning

Site Concept Plan #1

Discussion on the inclusion of walking trails and a dog park as part of the site concept plan.

PROS

Connectedness, Many new features, Utilizes existing development.

CONS

Some features are costly, Nonoptimal parking, Roundabout is large.

Parking County

Four parking lots 540 parking spaces (473 Ed Taylor, 67 Soccer)

Soccer Complex and Indoor Training Facility

Concept #1: Add a field to the top area. Widen the two-way road for better access. Additional features: Handicap parking, Field walker for accessibility, Boardwalk around the creek.

Playground Location

Discussed relocating the playground to the far end of the soccer complex. The current proposed location as less ideal.

Site Concept Plan # 2

PROS

Playground location, Alternative exit to Ed Taylor Soccer Field, Sidewalks to access all soccer fields, Ample land to plant trees.

CONS

Large amount of concrete to be placed and removed, 1-ways can be confusing or messy if people ignore the traffic pattern.

PARKING COUNT

Three parking lots, 760 parking spaces, (630 Ed Taylor, 130 Soccer)

Site Concept #3

PROS

Tennis Pavillon and Central Concession, Secluded Grass and Play Area, Cost Effective

CONS

No Alternative Access to the Neighborhood

PARKING COUNT

Seven parking lots, 758 parking spaces, (570 Ed Taylor, 188 Soccer)

Concept #3 was deemed the least favorable.

Concept #2 was preferred for parking layout and ease of access.

Suggestion to align the additional car park north-south instead of east-west.

Connect parking to the football field's existing parking lot, Eliminate the side road, Proposed redesign for park exits, Include a turn lane and separate left and right exit options, Add an "exit-only" at the backside to improve traffic flow, not present in the current plan.

Skate Park and Multipurpose Court

Concept #3 included additional parking closer to the skate park.

Proposal for a multipurpose court to support basketball, pickleball, tennis, and other activities beyond skateboarding.

Concession and Bathroom Facilities

Proposal to move concession stands and bathrooms to a more central location.

Consider using the upstairs area of the facility for office space.

Football Parking

Pull the car park closer to the field for better accessibility and increased space.

Finalizing Concepts

Students refine concepts based on feedback and return in January for review.

Focus on developing a single concept for presentation in May.

Price Estimates

Option 1: No changes; cost estimated at \$4,165,000 - \$7,940,000 00 for aesthetic improvements.

Option 2: \$3,351,000 - \$6,402,000.

Option 3: \$2,650,000 - \$4,825,000. Redesigning parking lot areas; cost to be determined.

Additional Suggestions

Ensure netting or fencing is included in the plans (SPLOST funding).

Lighting improvements for safety and usability.

Land Acquisition and Expansion

Discussion on acquiring private property near the softball field.

Potential land swap or purchase to expand areas near Highway 36.

Develop trails connecting soccer fields to other areas.

Master Plan Development

Redesign Field 1 into three fields to maximize space.

A 10-year master plan to address space constraints and future needs.

Final concept presentation scheduled for May.

- 1. 2nd Reader Ordinance 2024-11 Animal Shelter

Animal Shelter Director Tyler White (Mr. White) addressed the board with a few changes to Ordinance 2024-11. Mr. White said After questions, comments, and concerns, he removed Sec. 2.4.24. "Maximum Animals Allowed; the original purpose of that section was to regulate the number of animals allowed outside on two (2) acre tracts within Lamar County. After debate, conversation, and consideration, Sec. 2.4.24. has been replaced with a new ordinance named Prohibition on Rehoming Stray Animals Without Notification, and it's intended purpose is to identify Lamar County Animal Shelter as the lost and found center for stray animals, mandating that any animal picked up from the side of the road or private property be reported to Lamar County Animal Shelter, and microchip checked at either the shelter or local veterinary clinic to increase the chance of pet owner's reunification with their pets, and to protect pet owners' rights while also ensuring stray animals are properly identified before rehoming a stray animal."

Mr. White shared with the board that he had a discussion with Mrs. Norma Greenwood about barking dogs in the neighborhood. He stated Mrs. Greenwood has a leading role with Dolly Goodpuppy.

Commissioner Gilles addressed Mr. White via Commissioner Lovett's phone. She said she had concerns with the care of the animals versus how many animals and requested that this part be taken out of the Ordinance. Mr. White said he removed and added in a section regarding re-homing animals without notification. The purpose being to recentralize the Lamar County Animal Shelter as a lost and found service. He said if someone picks up an animal on the side of the road it is there duty by Ordinance to report it to Animal Control that the animal was found and work with the local animal clinics to identity the animal in case someone comes looking for the animal at the Animal Shelter so it can be reunited with its owner. Commissioner Gilles stated she appreciated all of the hard work Mr. Tyler has been doing with the Animal Shelter.
