Special Election - March 21, 2023



To Vote:

1. Use Black or Blue Ink to mark the ballot.
2. Completely fill in the empty oval to the left of the candidate name or choice in all races you wish to vote.
3. If voting for a Write-In candidate, completely fill in the oval to the left of the Write-In selection, then write the name of the Write-In candidate in the space provided.

Warning

- Do NOT use red ink or felt tip pen to mark ballot.
- Do NOT circle, underline or mark through choices.
- Do NOT use check marks or X to mark ballot.
- Do NOT mark more choices per race than allowed.
- Do NOT sign, cut, tear or damage the ballot.

If you make a mistake or change your mind on a selection:

- A. Do not attempt to mark through the selection or attempt to erase. Write "**Spoiled**" across **the ballot AND across the return envelope**.
- B. Mail or return the spoiled ballot and envelope to your county board of registrars; a new official absentee ballot will be mailed to you.

If you decide to vote in-person: Surrender the ballot to the poll manager at an early voting site within your county or the precinct to which you are assigned. You will then be permitted to vote a regular ballot.

"I understand that the offer or acceptance of money or any other object of value to vote for any particular candidate, list of candidates, issue, or list of issues included in this election constitutes an act of voter fraud and is a felony under Georgia law." [O.C.G.A. 21-2-284(e), 21-2-285(h) and 21-2-383(a)]

Lamar County SPLOST (Vote for One)

Shall a special one percent (1%) sales and use tax be imposed in the Special District of Lamar County for a period of time not to exceed six years (24 calendar quarters) to commence upon the termination of the one percent (1%) sales and use tax presently in effect, and for the raising of an estimated amount of \$14,400,000 for the following purposes pursuant to an Intergovernmental Agreement among Lamar County, Georgia, the City of Barnesville, the City of Milner, and the Town of Aldora:

(1) LAMAR COUNTY – Capital outlay projects for the use and benefit of the citizens of Lamar County at an estimated cost \$8,208,000 consisting of:

- (A) Acquisition of law enforcement vehicles and other public vehicles; and
- (B) Construction of improvements to enhance public fire protection; and
- (C) Public park improvements, acquisition, additions and related equipment; and
- (D) Renovation of public facilities and acquisition of related equipment.
- (E) Acquisition of public works equipment; and
- (F) Paving, resurfacing and construction of roads, streets and bridges.

(2) CITY OF BARNESVILLE – Capital outlay projects for the City at an estimated cost of \$5,472,000 consisting of:

- (A) Improvements to Water and Sewer System; and
- (B) Equipment; and
- (C) Construction and Renovation of Public Facilities; and
- (D) Paving, Resurfacing and Construction of Roads.

(3) CITY OF MILNER – Capital outlay projects for the City of an estimated cost of \$576,000 consisting of:

- (A) Improvements to police facilities and the acquisition of related equipment.
- (B) Improvements to water and sewer system; and
- (C) Public park improvements, acquisition, additions and related equipment; and
- (D) Renovation of city hall and the police station; and
- (E) Acquisition of public works related equipment; and
- (F) Paving, resurfacing and construction of road, streets, and sidewalks.

(4) TOWN OF ALDORA – Capital outlay projects for the Town at an estimated cost of \$144,000 consisting of:

- (A) Improvements to stormwater system; and
- (B) Landscaping of Town rights of way and property; and
- (C) Renovations to public projects and purchase of related equipment and property; and
- (D) Paving, resurfacing and construction of roads, streets, and sidewalks.
