## Meeting Summary Workshop Meeting Lamar County Board of Commissioners 5/11/2023 12:30 p.m.

The meeting was called to order at approximately 12:30 p.m. on May 11<sup>th</sup>, 2022. Present for the meeting were Chairman Traylor Vice-Chair Thrash, Commissioner Fletcher, Commissioner Lovett, Commissioner Gilles, and County Clerk Davidson. County Administrator Townsend was absent for the meeting.

- 1. The board heard a presentation from Industrial Development Authority (IDA) Director Kathy Oxford regarding expectations of New Business, Workforce Development, Marketing and Economic Development.

The board heard concerns and a request from Recreation Director Lowe regarding traffic at the top of hill baseball field and having an easement of some type that would go into Redbud Drive to ease the flow of traffic in case of an emergency or some type of special egress for Emergency Medical Services (EMS).
- 4. Tax Assessor Jeannie Haddock presented an understanding of the new assessment as it relates to the "Fair Market Value". The assessed value is forty percent (40%) of the fair market or 100% value. If the fair market value of a property in this county is \$100,000 times .40(40%) to get the assessed value. The board has continuously used the rollback of the Local Option Sales Tax to determine the millage rate and for the last four years they have decreased the millage rate from 13.1570 down to 11.0050.
- 5. The board discussed the Coffey Road extension and the possibility of abandoning the road so that the County does not have to maintain that portion of the road.
- 6. The board discussed the possibility of lowering the speed limit on Five Points Road.
