Mr. Townsend and Ms. Buice leave the executive session at 2:54 pm.


Mr. Townsend rejoins the executive session at 3:23 pm.


Ms. Buice rejoins the executive session at 3:41 pm.

The Board reconvenes in regular session at 4:04 pm on motion by Commissioner Fletcher, seconded by Commissioner Lovett and approved 4-0.


